## **Important Assessment Information for All Property Owners**

The assessment for developed lots will be \$575.00 and for undeveloped lots it will be \$525.00.

The following is the payment schedule for 2016:

March 15 <sup>th</sup>	Assessment Notices mailed out to members
May 31 <sup>st</sup>	Full assessment due
June 1 <sup>st</sup> until August 30 <sup>th</sup>	Late charges apply
September 1 <sup>st</sup>	Delinquent accounts forwarded for collection process

You do not have to wait for the assessment notice to arrive at your home to pay, if you would like to pay your assessment earlier that is fine.

If you need/want a **payment plan**, apply for one right away using the instructions in your Assessment Notice. We will try as much as possible to work with you. The board has put into practice a new form for payment arrangements when one is needed.

#### Legal Fees:

There are several property owners whose accounts are delinquent and are in the process of being collected upon. This causes an additional outlay of money for the homeowner when settlement is finally reached. To avoid this, please pay the assessment on time. In addition, this also causes problems in regards to our budget.

#### **Roads:**

Chip and tar was done on a section of Big Oak Rd. It is <u>very important</u> that members attend the Annual Meeting on June 11, 2016 to discuss further laying of chip and tar on the roads and the budget. As a reminder, per the Spruce Hill Farms Property Owners Association Rules and Regulations, PO 8. Drainage: Each property owner shall keep drainage ditches, swales and culvert pipes located on their lot free and unobstructed and in good repair. Each property owner is responsible for any culvert pipes needed on their lot to control the flow of water so as not to cause damage to the development's roadways.

### Pool:

We were able to save some money this year from the pool budget by hiring lifeguards directly. In addition, money that was allocated to the neighborhood party in the pool budget was removed to lower the 2015/2016 budget for the pool. As a reminder, no pool pass will be issued to a property owner unless dues are fully paid. Remember there is a Facebook page under Spruce Hill Farms Pool to express your opinions/ideas in regards to the pool.

#### **Gypsy Moths:**

We contacted the Monroe County Planning Commission and PA DCNR in regards to spraying for gypsy moths this upcoming spring. The cost would be \$54/acre for 364 acres through the spray program with the County and DCNR. We would normally pay 50% of this cost. Unfortunately, PA DCNR is getting less funding from the USDA Forest Service this year for spraying so the County is collecting the full cost at \$54/acre. Based on our budget for the Association, we cannot afford this expense.

#### **Dogs:**

Some property owners have made mention about other property owner's dogs. As a reminder, Spruce Hill Farms Rule and Regulations states the following:

PO 4. <u>PETS</u>: Barking dogs must be kept in the enclosed part of the house. When dogs are out of the house, they must be leashed at all times, and kept under the owner's control. Noisy pets are to be controlled by their owner. Pets are not allowed to enter the pool area, recreation area, or any common area, except roads. Pets must be licensed and inoculated, according to Pennsylvania State Laws. It is the responsibility of the owner of the pet to clean up and to remove animal excrement. The keeping of any animal other than those classified as household pets is prohibited.
