Highlights:

Chip and tar on Pine Tree, Spruce, and Birch.

This year we plan to chip and tar the entire length of Big Oak and the turns plus 50 feet at Hemlock and Cedar. We will fog coat the roads that already have chip and tar on them. Signs will be posted when this work is occurring, sometime towards the end of June.

Plan is to chip and tar Maple and Hemlock next year and the following year to do Cedar and the very end of Birch. Cedar is last because some of the drainage pipes need to be replaced before the work can be done. The floor was opened to questions.

General Issues/New Business

New business was presented by Susan Gebase. Gypsy Moths: A contractor came into our community and did a survey for gypsy moths. We received a quote of about \$11,000 (~\$48/acre) to spray the community. The contractor stated we had some heavy infested areas on Big Oak but not much anywhere else, so it was decided not to spray. Monroe County was contacted in regards to the gypsy moths and it was stated that Barrett Township voted against participating in spraying. They also stated spraying is \$27/acre. The Monroe County contact who is responsible for coordinating the spraying is Christine Fritz. Ms. Fritz stated there was a meeting coming up with PA DCNR to discuss the gypsy moth situation and what to do next year. It was stated we are at peak for the gypsy moths and we should start to see a decline. Tallman Arial Spraying conducts the spraying in our area but they will not deal directly with the public, they will deal directly with the County or a contractor.

Pat Williams Lot 413 was offended that sign at entrance of community for annual meeting stated "all **must** attend". It was discussed how to correct. A new sign would cost more money and that is not a feasible solution. A motion was made to tape over the must but the motion was declined since this may look unsightly.

A member asked why members cannot have "For Sale" signs. It is stated in the Rules and Regulations.
